## **2024** Accreditation Standards Implementation and Updated Resources

Dear Colleagues,

It is hard to believe that another summer has passed and I am writing to you on the cusp of a new semester. Over the summer, ACCJC staff have been busy developing resources and trainings for the 2024 Accreditation Standards Implementation. We just conducted our first webinar introducing the Standards and appreciated the opportunity to highlight the key changes in the Standards and related processes, answer questions, and engage in conversation with the field about the implementation. For those who could not attend, a second webinar will be held on October 10<sup>th</sup>. And, I'm pleased to share that the new <u>ACCJC Accreditation Handbook</u> has launched and is available on the ACCJC website.

In the process of designing and adopting the 2024 Accreditation Standards, we noted several improvements to the process, including extending the accreditation cycle to eight years, revising the Midterm Report, streamlining the ISER, and redesigning training and engagement for stakeholders and peer reviewers.

Finally, thank you to all 27 institutions who have volunteered to serve as pilot colleges and to the peer reviewers who are serving on the upcoming pilot peer review teams. The feedback received and lessons learned through the pilot reviews will be sure to guide future updates and additions to processes and resources.

I am looking forward to connecting with more of you over the next year as I continue the <u>ACCJC On The Move</u> project, participate in upcoming webinars, and attend various industry meetings and events. As always, please reach out if there is a way I can serve you and best of luck in your work this semester!

## **2024 Accreditation Standards Implementation and Resources**

ACCJC's 2024 Accreditation Standards reflect the diversity of ACCJC member institutions, are streamlined and clear, emphasize equity and inclusion, and are focused on outcomes and improvement rather than processes. To aid in the implementation of the new Standards, ACCJC has developed several resources that are available on the Accreditation Handbook and Report Templates Page of the ACCJC website:

#### ACCJC Accreditation Handbook

The ACCJC Accreditation Handbook provides an overview of ACCJC's comprehensive system of resources and collaborative practices that promote continuous quality improvement and advance equitable student outcomes. The Handbook is intended to serve as the primary reference for guiding institutions and review teams through the institutional evaluation process and to assist accreditation review teams and the Commission to fairly and consistently evaluate institutions. It is the Commission's hope that the Handbook will be a helpful resource for a variety of readers, including representatives of institutions accredited by the Commission, institutions seeking accreditation, peer reviewers, and the general public.

The Handbook is a comprehensive replacement for most of ACCJC's guides and manuals such as the Guide to Institutional Self-Evaluation, Improvement, and Peer Review; the Guide for Peer Review Team Members; the Accreditation Liaison Officer (ALO) Guide; and the Team Chair and Vice Chair Manual.

#### <u>Updated ISER Template and other Report Templates</u>

The Institutional Self-Evaluation Report (ISER) is required for all institutions as part of a comprehensive review. The ISER provides narrative and evidence documenting alignment with Standards. The updated template reflects streamlined ISER expectations that get you directly into the evaluation and telling YOUR story. The evaluation approach is more holistic in terms of providing a clear sense of mission alignment throughout each Standard area; focuses on equitable outcomes, innovation, and improvement; and allows for more consideration of strengths and success stores. The template includes embedded instructions for each section of the report, suggested length for narrative responses, and checklists for required documentation.

In addition to the Update ISER Template, templates for other ACCJC reports are available on the <u>Accreditation</u> <u>Handbook and Report Templates Page</u> of the ACCJC website. The updated Midterm Report Template and Peer Review Team Report Templates are coming soon.
