The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting January 15-17, 2020, reviewed the Follow-Up Report and related evidentiary materials submitted by Barstow College. The purpose of this review was to determine whether the College has appropriately responded to the issues as identified by the peer review team at the time of the last visit and as expressed in the Commission's Action Letter of June 13, 2018 and whether the College has demonstrated compliance with the related Standards. Additionally, the Commission considered the spoken testimony of you, Dr. Karen Kane, Executive Vice President, and Ms. Lisa Holmes, Accreditation Liaison Officer. The Commission found these additional perspectives to be helpful.

Upon consideration of the information noted above, the Commission acted to find continued non-compliance, and **Grant a Good Cause Extension**. The Commission finds that Barstow College has addressed the compliance requirements 2, 3, and 4, corrected deficiencies, and meets Standards III.A.5, III.A.13, III.B.4, III.C.2. The Commission finds that the College has not addressed Standards I.B.2, II.A.13 (College Recommendation 1). The College is required to submit a **Follow-Up Report by November 15, 2020** to address the remaining deficiencies noted in College Recommendation 1. The accredited status of the institution continues during the good cause extension period.

The Commission requires the College to disseminate the Follow-Up Report, and this letter within the institution, including by posting them on the College's website.

On behalf of the Commission, I wish to express appreciation for the diligent work and thoughtful reflection that it undertook to respond to these requirements. These efforts confirm that peer review can well serve the multiple constituencies of higher education by both ensuring and encouraging institutional quality and effectiveness.

Dear President Bagg:

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting June 6-8, 2018, reviewed the Institutional Self Evaluation Report (ISER) and evidentiary materials submitted by Barstow Community College. The Commission also considered the External Evaluation Team Report (Team Report) prepared by the peer review team that conducted its onsite visit to the College March 5-8, 2018.

The purpose of this review was to determine whether the College continues to meet ACCJC's Eligibility Requirements, Commission Policies, and Accreditation Standards (hereinafter, the Standards). Upon consideration of the written and oral information noted above, the Commission acted to Reaffirm Accreditation for 18 months and require a Follow-Up Report, due October 1, 2019.

Commendations

The Commission recognizes the exemplary performance of Barstow Community College in the following areas. Commendations signify practices for which the Commission believes the insitution has exceeded standards.

Commendation 1: The team commends the College for making significant structural changes to its counseling services that have resulted in a more integrative approach to providing students with timely, useful, and accurate information, enhancing student retention and completion. By physically distributing the counselors throughout the college, and assigning specific cohorts, the college has improved the advisory experience for all students. A high-touch approach involving outreach to at-risk students and the use of peer advisors has yielded further positive results, particularly in relation to retention. (III.C.3, II.C.5)

The Commission also determined that the College must demonstrate compliance with the following Standards, as addressed in the College recommendations. This demonstration must be addressed in the required Follow-Up Report.

Standard I.B.2, II.A.3 (College Recommendation 1): In order to meet the standard, the Commission requires that the College assess program level outcomes for all instructional programs to assure currency, improve teaching and learning strategies, and promote student success.

Standard III.A.5 (College Recommendation 2): In order to meet the standard, the Commission requires that the College to systematically evaluate employees at stated intervals.

Standard III.A.13 (College Recommendation 3): In order to meet the standard, the Commission requires that the College update the code of ethics for personnel to include the consequences for violation.

Standard III.B.4, III.C.2 (College Recommendation 4): In order to meet the standard, the Commission requires that the College address the total cost of ownership for physical and technological resources in support of the Colleges' mission, operation, programs, and services.

In accordance with federal regulations, compliance requirements must be addressed and the institution must demonstrate that it aligns with Standards within two years¹.

Recommendations for Improving Institutional Effectiveness

The Team Report noted College Recommendation 5 for improving institutional effectiveness. This recommendation does not identify current areas of deficiency in institutional practice, but consistent with its mission to foster continuous improvement through the peer review process, the Commission encourages institutions to give serious consideration to the advice contained in the peer reviewers' recommendations. The Commission anticipates that you will bring them and the team's full report to the attention of your institution for serious consideration. In the Midterm Report, the College will include actions taken in response to the peer review team's improvement recommendations.

Next Steps

The Team Report provides details of the peer review team's findings with regard to the College's work to meet Standards. The guidance and recommendations contained in the Report represent the best advice of the peer review team at the time of the visit but may not describe all that is necessary for the college to improve or to come into compliance. A final copy of the team report is attached.

The Commission requires that you disseminate the ISER, the Team Report, and this letter to those who were signatories of the ISER and that you make these documents available to all campus constituencies and the public by placing copies on the College website. Please note that in response to public interest in accreditation, the Commission requires institutions to post current accreditation information on a Web page no more than one click from the institution's home page. In keeping with ACCJC policy, the Commission action will also be posted on the ACCJC website within 30 days of the date of the Commission's action.
