The Accrediting Commission for Community and Junior Colleges, at its meeting January 10 - 11, 2024, reviewed the Institutional Self-Evaluation Report (ISER) and evidentiary materials submitted by Chaffey College. The Commission also considered the Peer Review Team Report (Team Report) prepared by the peer review team that conducted its site visit to the College September 18 - 19, 2023.

In keeping with ACCJC policy, the Commission action will also be posted on the ACCJC website within 30 days of the date of the Commission's action.

The next report from the College will be the Midterm Report¹ due on October 15, 2027. The institution's next comprehensive review will begin with Team ISER Review in the spring term of 2030 and conclude with a Focused Site Visit in the fall term of 2030.

On behalf of the Commission, we wish to express appreciation for the diligent work and thoughtful reflection that Chaffey College undertook to prepare for this review. These efforts confirm that peer review can serve the multiple constituencies of higher education by both ensuring and encouraging institutional quality and effectiveness.
