The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting June 9-11, 2021, reviewed the Follow-Up Report and related evidentiary materials submitted by College of San Mateo. The Commission also considered the Peer Review Team Follow-Up Report prepared by the follow-up team that visited the institution on April 14, 2021. The purpose of this review was to determine whether the College has addressed the deficiencies identified by the peer review team during the fall 2019 comprehensive visit and demonstrated compliance with the Standards cited in the Commission's January 27, 2020 Action Letter.

Upon consideration of the information noted above, the Commission acted to **Reaffirm Accreditation** for the remainder of the cycle. The Commission finds that College of San Mateo has addressed the compliance requirements, corrected deficiencies, and meets Standard II.A.2 and the *Policy on Distance Education and Correspondence Education*. The Commission requires the College to disseminate the Follow-Up Report, the Team Report, and this letter within the institution, including by posting them on the College's website.

The next report from the College will be the Midterm Report<sup>1</sup> due on October 15, 2023. The institution's next comprehensive review will begin with Team ISER Review in the spring term of 2026 and conclude with a Focused Site Visit in the fall term of 2026.

Dear Dr. Lopez:

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting January 15-17, 2020, reviewed the Institutional Self Evaluation Report (ISER) and evidentiary materials submitted by the College of San Mateo. The Commission also considered the Peer Review Team Report (Team Report) prepared by the peer review team that conducted its onsite visit to the College September 30 – October 3, 2019.

The purpose of this review was to determine whether the College continues to meet ACCJC's Eligibility Requirements, Commission Policies, and Accreditation Standards (hereinafter, the Standards). Upon consideration of the written information noted above, the Commission acted to Reaffirm Accreditation for 18 months and Require a Follow-Up Report, due no later than March 1, 2021, followed by a visit from a peer review team.

The Commission recognizes the exemplary performance of the College of San Mateo in the following areas. Commendations signify practices for which the Commission believes the insitution has exceeded standards.

College Commendation 1: The Commission commends the College on its significant and effective variety of learning support for students including the Learning Center, discipline-specific labs, and library. (II.B.1)

**College Commendation 2:** The Commission commends the College for its progressive and collaborative governance and planning processes, leading to a culture of trust. (IV.A.1, IV.A.5)

**College Commendation 3:** The Commission commends the College for the collaboration between its CTE programs and local industry partners. The networking, communication, and cooperation for the purpose of curriculum development student learning, and program enhancement is impressive. (II.A.14)

**District Commendation 3:** The Commission commends the District for its support and implementation of the City University of New York (CUNY) ASAP replication program. This approach provides a progressive approach in system-wide support for students and invests significant resources in student success and equity. (II.C.3)

### Compliance Requirements

The Commission also determined that the College must demonstrate compliance with the following Standards, as identified in the College recommendations. This demonstration must be addressed in the required Follow-Up Report.

Policy on Distance Education and Correspondence Education; Standard II.A.2 (College Requirement 1): In order to meet the standard, the Commission requires that the college establish a policy defining regular and substantive instructor-initiated contact with students for Distance Education courses. The Commission requires that the college provide professional development opportunities for faculty to ensure Distance Education courses include regular and substantive instructor-student interaction.

In accordance with federal regulations, compliance requirements must be addressed and the institution must demonstrate that it aligns with Standards within two years<sup>1</sup>.
