The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting January 12-14, 2022, reviewed the Follow-Up Report and related evidentiary materials submitted by Imperial Valley College. The Commission also considered the Peer Review Team Report prepared by the follow-up team that visited the institution on November 16, 2021. The Commission appreciated your spoken remarks, as well as those of Ms. Yolanda Catano, Interim Associate Dean of Institutional Effectiveness, and Dr. Jia Sun, Accreditation Coordinator/Professor. The purpose of this review was to determine whether the College has addressed the deficiencies and demonstrated compliance with the Standards cited in the Commission's February 1, 2021, Action Letter.

Upon consideration of the information noted above, the Commission acted to **Reaffirm** Accreditation for the remainder of the cycle. The Commission finds that Imperial Valley College has addressed the compliance requirements, corrected deficiencies, and meets Standards I.B.7 and I.B.9. The Commission requires the College to disseminate the Follow-Up Report, the Follow-Up Peer Review Team Report, and this letter within the institution, including by posting them on the College's website. A final copy of the Follow-Up Peer Review Team Report is attached.

The next report from the College will be the Midterm Report¹ due on March 15, 2023. The institution's next comprehensive review will begin with Team ISER Review in the fall term of 2025 and conclude with a Focused Site Visit in the spring term of 2026.

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting January 13-15, 2021, reviewed the Follow-Up Report and related evidentiary materials submitted by Imperial Valley College. The purpose of this review was to determine whether the College has appropriately responded to the issues as identified by the peer review team at the time of the last visit and as expressed in the Commission's Action Letter of June 28, 2019, and whether the College has demonstrated compliance with the related Standards.

Upon consideration of the information noted above, the Commission finds that Imperial Valley College has addressed Compliance Requirement 1, corrected deficiencies, and meets Standards I.B.2, II.A.3, and II.B.3. The Commission further finds continued noncompliance with Standards I.B.7 and I.B.9 (Compliance Requirement 2), and acted to **grant a Good Cause Extension**. The College is required to **submit a Follow-Up Report by November 1, 2021**, which will be followed by a visit from a peer review team. The Follow-Up Report should address the remaining deficiencies noted in Compliance Requirement 2. The accredited status of the institution continues during the good cause extension period.

The Commission requires the College to disseminate this Follow-Up Report, and this letter within the institution, including by posting them on the College's website. The Commission looks forward to receiving the College's second Follow-Up Report to address the deficiencies. The Commission has granted as much time as allowable under Federal regulations and will be obligated to take an adverse action if the Standards are not met.

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting June 5-7, 2019, reviewed the Institutional Self Evaluation Report (ISER) and evidentiary materials submitted by Imperial Valley College. The Commission also considered the External Evaluation Team Report (Team Report) prepared by the peer review team that conducted its onsite visit to the College March 11-14, 2019.

The purpose of this review was to determine whether the College continues to meet ACCJC's Eligibility Requirements, Commission Policies, and Accreditation Standards (hereinafter, the Standards). Upon consideration of the written and oral information noted above, the Commission acted to reaffirm accreditation for 18 months and require a Follow-Up Report, due no later than October 1, 2020.

The Commission recognizes the exemplary performance of Imperial Valley College in the following areas. Commendations signify practices for which the Commission believes the insitution has exceeded standards.

Commendation 1: The team commends the College for its comprehensive and reliable services to students regardless of service location or delivery of services. This was exemplified by the implementation and tremendous success of students participating in its Inside Out Program for incarcerated students, in addition to programs that connect individuals to the college such as the Health Center and the IVC Kitchen with the Developing Garden. (II.C.3)

Commendation 2: The team commends the College for establishing the Teaching and Learning Center (TLC), as well as the associated faculty and staff that have created an impressive resource-rich environment to nurture faculty innovation. (III.C.4)

Commendation 3: The team commends the College for its commitment to students and their success and the transformation of the community as a whole through higher education. There is an organizational culture focused on students that permeates the faculty, staff, and administration. The community also expresses how strongly they feel about the value and role the college plays in being a beacon of hope and change in the region. (IV.A.1, IV.A.5, IV.B.6)

Compliance Requirements

The Commission also determined that the College must demonstrate compliance with the following Standards, as identified in the compliance requirements. This demonstration must be addressed in the required Follow-Up Report.

- 1. **Standard I.B.2, II.A.3, II.B.3 (College Recommendation 1)**: In order to meet the standards the Commission requires the college to engage in a robust learning outcomes assessment process that is consistent and comprehensive to improve all programs and services.
- 2. **Standards I.B.7, I.B.9** (College Recommendation 2): In order to meet the standards the Commission requires the college to improve the evaluation of processes and systems that are currently in place, and ensure they are more systematic and routine.

In accordance with federal regulations, compliance requirements must be addressed and the institution must demonstrate that it aligns with Standards within two years¹.

Recommendations for Improving Institutional Effectiveness

The Team Report noted Recommendations 3, 4, 5 for improving institutional effectiveness. These recommendations do not identify current areas of deficiency in institutional practice, but consistent with its mission to foster continuous improvement through the peer review process, the Commission encourages institutions to give serious consideration to the advice contained in the peer reviewers' recommendations. The Commission anticipates that you will bring them and the team's full report to the attention of your institution for serious consideration. In the Midterm Report, the College will include actions taken in response to the peer review team's improvement recommendations.

Next Steps

The Team Report provides details of the peer review team's findings. The guidance and recommendations contained in the Report represent the best advice of the peer review team at the time of the visit but may not describe all that is necessary for the college to improve or to come into compliance. A final copy of the Team Report is attached.

The Commission requires that you disseminate the ISER, the Team Report, and this letter to those who were signatories of the ISER and that you make these documents available to all campus constituencies and the public by placing copies on the College website. Please note that in response to public interest in accreditation, the Commission requires institutions to post current accreditation information on a Web page no more than one click from the institution's home page. In keeping with ACCJC policy, the Commission action will also be posted on the ACCJC website within 30 days of the date of the Commission's action.
