The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting June 5-7, 2019, reviewed the Follow-Up Report and related evidentiary materials submitted by Modesto Junior College. The Commission also considered the External Evaluation Team Follow-Up Report prepared by the follow-up team that visited the institution on March 28, 2019. The purpose of this review was to determine whether the College has appropriately responded to the issues as identified by the peer review team at the time of the last visit and as expressed in the Commission's Action Letter of January 26, 2018, and whether the College has demonstrated compliance with the related Standards.

Upon consideration of the information noted above, the Commission acted to **find compliance and reaffirm accreditation for the remainder of the cycle**. The Commission finds that Modesto Junior College has addressed the compliance requirements, corrected deficiencies, and meets Standards II.A.7, III.B.4, III.C.2, IV.C.7, and IV.C.12. The next report from the College will be the Midterm Report¹ due on October 15, 2021. The institution's next comprehensive review will occur in the fall term of 2024.

The Commission requires the College to disseminate the Follow-Up Report, the Team Report, and this letter within the institution, including by posting them on the College's website.

On behalf of the Commission, I wish to express appreciation for the diligent work and thoughtful reflection that Modesto Junior College undertook to respond to these requirements. These efforts confirm that peer review can well serve the multiple constituencies of higher education by both ensuring and encouraging institutional quality and effectiveness.

Dear President Stearns:

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting January 10-12, 2018, reviewed the Institutional Self-Evaluation Report (ISER) and evidentiary materials submitted by Modesto Junior College. The Commission also considered the External Evaluation Team Report (Team Report) prepared by the peer review team that conducted its onsite visit to the College Monday, October 2 - Thursday, October 5, 2017. The Commission considered the spoken testimony of Dr. James Todd, Chancellor Henry Yong, and team chair Dr. Loretta Adrian at the Commission meeting. The Commission found these additional perspectives to be helpful.

The purpose of this review was to determine whether the College continues to meet ACCJC's Eligibility Requirements, Commission Policies, and Accreditation Standards (hereinafter, the Standards). Upon consideration of the written and oral information noted above, the Commission acted to **Reaffirm Accreditation for 18 months and require a Follow-Up Report due no later than March 1, 2019**, followed by a visit from a peer review team.

Compliance Requirements

The Commission also determined that the College must demonstrate compliance with the following Standards, as addressed in the College and District recommendations. This demonstration must be addressed in the required Follow-Up Report.

1. **Standard II.A.7 (College Recommendation 4):** In order to ensure compliance with accreditation Standards, Commission Policies, and USDE Regulations regarding Distance Education and Correspondence Education, the college must review and revise its existing processes to ensure that faculty teaching online courses consistently provide regular and substantive interaction with students.
2. **Standard III.B.4 and III.C.2 (District Recommendation 1):** In order to meet the standard, the District must address the total cost of ownership for physical and technological resources in support of the Colleges' missions, operations, programs, and services.
3. **Standards IV.C.7 and IV.C.12 (District Recommendation 4):** In order to meet the Standards, the Board must fully delegate operational authority to the Chancellor and the College Presidents as specified in Board Policies 2430 and 2430.1, and demonstrate through practice, their policy making role while refraining from interfering with the CEO's authority to operate the District/Colleges.

In accordance with federal regulations, compliance requirements must be addressed and the institution must demonstrate that it aligns with Standards within two years¹.

Modifications to Recommendations

In taking its action, the Commission modified the team's recommendation(s) as follows:

The Commission determined that the College is in compliance with Standard III.B.1 and so removed Standard III.B.1 from the citations for **District Recommendation 1**.

Recommendations for Improving Institutional Effectiveness

The Team Report noted College Recommendations 1, 2, 3, and 5 and District Recommendations 2 and 3 for improving institutional effectiveness. These recommendations do not identify current areas of deficiency in institutional practice, but consistent with its mission to foster continuous improvement through the peer review process, the Commission encourages institutions to give serious consideration to the advice contained in the peer reviewers' recommendations. The Commission anticipates that you will bring them and the team's full report to the attention of your institution for serious consideration. In the Midterm Report, the College will include actions taken in response to the peer review team's improvement recommendations.

Next Steps

The Team Report provides details of the peer review team's findings with regard to the College's work to meet Standards. The guidance and recommendations contained in the Report represent the best advice of the peer review team at the time of the visit but may not describe all that is necessary for the college to improve or to come into compliance. A final copy of the team report is attached.

The Commission requires that you disseminate the ISER, the Team Report, and this letter to those who were signatories of the ISER and that you make these documents available to all campus constituencies and the public by placing copies on the College website. Please note that in response to public interest in accreditation, the Commission requires institutions to post current accreditation information on a Web page no more than one click from the institution's home page. In keeping with ACCJC policy, the Commission action will also be posted on the ACCJC website within 30 days of the date of the Commission's action.

The College's Midterm Report² will be due on October 15, 2021. The institution's next comprehensive review will occur in the fall term of 2024.
